REMOTE VIEW!

We can now offer the ability to watch a camera in your home from anywhere, or watch your business from home or on vacation. Several options are available, including a low cost system with offsite video storage, so you don't even need your own recorder. With I-See Video, we install 1 or 2 cameras in your building, connect to your high-speed internet equipment, and guide you on viewing the cameras from anyplace you have a computer with high-speed internet service. There are advanced settings to record only when there is motion in front of the camera, or on a schedule. The system even offers remote control to turn the cameras top-to-bottom and side-to-side by remote control. The video is stored on a remote server. Although there is a monthly cost for this service, the first year is included in the system cost.

If you already own a camera system, we also offer a gateway device with similar service, but it can be connected to up to 4 existing analog cameras. There are also services available to view your digital video recorder over the internet, using a web browser. Again, high-speed internet is required at the camera site and where you are remotely viewing from.

RESIDENTIAL PHONE LINE OPTIONS

It appears that residential phone lines are slowly disappearing from the landscape. Verizon Communications, long one of the major providers of phone lines in Michigan, recently announced their intention to sell their landlines, and get out of the copper phone line business entirely. We are seeing a number of customers asking about alternatives to a phone line for their alarm system, as many are switching to cell phones or Voice over Internet Protocol (VoIP) phone service. We appreciate the calls, because some VoIP providers (AT&T, Comcast, Broadstripe) have the capability to make their phone service compatible with alarm systems, and other providers service is not compatible with alarm systems, which prevents us from receiving signals.

In order to accommodate customers who want to remove their phone line, we have several options, including cellular, radio, and internet communicators. We are now offering a promotional price of \$396.00 to install one of these devices in your building. That amounts to \$33.00 per month, which is approximately what you would save by discontinuing your land-line service. We will invoice for that along with your monitoring invoice, so you don't need to pay for the equipment at the time of installation. Contact your sales representative for more information.

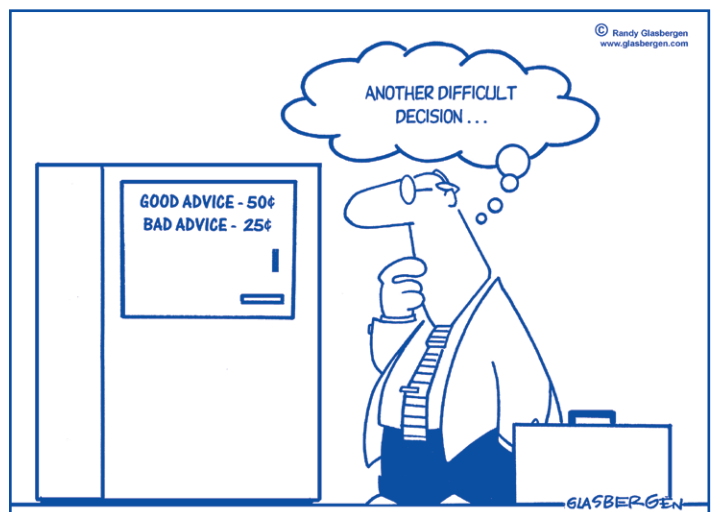
